Based on last night's meeting as well as several other encounters (documented) I believe Assemble members Morphet and Lende require direction regarding requesting HBPD to provide the blotter. As defined in Haines Borough Code Chapter 2.06 Code of Ethics - 2.06.030 Misuse of Official Position – subsection B(5) Attempt to affect a personal or financial interest through coercion of a subordinate. This matter has already been addressed by Borough Legal Counsel (see attached document), further Assemble member Morphet has addressed this same conflict of interest in his Blog http://www.tommorphet.com/assembly-issues/why-the-police-blotter-is-important/. Although Assemble member Lende has no financial interest she is affiliated with both CVN and KHNS and has interests in the welfare of these organizations.

Although not opposed to providing the blotter with appropriate resources, I am not in the same position to dialogue with the public and the Haines Borough as an elected official; not to mention ones with access to media resources.
