MISCONDUCT IN OFFICE

1. Failure to uphold the borough code. (Oaths of office 2.04.404)
2. Misuse of official position (HBC 2.06.300) On Dec.15/2015, at the Borough assembly meeting at about 1 hr. 1 min. 29 sec. Gregg made a statement that “ We can choose or not to choose to follow code”
3. Violation of the open meeting act (AS 44.62.310)
