1/11/17- EMAIL to the manager, Police Chief Scott complained

"Based on last night's meeting as well as several other encounters(documented) I believe Assembly members Morphet and Lende require direction regarding requesting HBPD to provide the blotter". Coercion of a subordinate in an attempt to affect a personal or financial interest is misuse of his official position. The interest he has is he stands to benefit through his connection with the CVN newspaper and his personal blog.

2. Individually directing the Manager (HBC 2.10.200A)

10/25/16-12:53 P.M- the Manager sent an email stating that he had been contacted by individual assembly members asking him not to open the harbor bids. At the 2:00 P.M. bid opening 10/25/16 Lende and Morphet told the manager they didn't want him to open the bids. Morphet was assembly member elect at the time. (HBC 2.06.990 Definitions of public officer includes assembly member elect.)

3. Violation of open meeting act (AS 44.62.310)

12/16- email Morphet, Lende, Gregg and Jackson communicating on the 33' harbor extension by email and or phone.

More than three assembly members cannot communicate outside of an official meeting about Borough business.
